There is a \$35 application fee, \$40 if paid the day of the audition and \$45 if applying by video. Checks should be made payable to Colorado Ballet Academy.

Video Audition Detailed Requirements: Colorado Ballet Academy gives first preference to students who audition in person. However, we do accept videos (non-returnable) if circumstances prevent you from attending a live audition. There is a \$45 video audition fee. The video must be within 3 months prior to submission and video must be received no later than **March 1, 2018**. The video must be submitted via Acceptd.com <https://getacceptd.com> Results will be communicated within three (3) weeks of receipt of video audition.
