



### Tuition Reduction Guidelines

Each year, through the support of generous foundations and individuals, Colorado Ballet is pleased to offer tuition reduction opportunities to students who wish to study ballet in our Academy. The number and amount of each award is determined by both the number of applicants and the amount of funds available. Tuition reduction amount is not guaranteed to be the same as awards made in previous years. Participants agree to the guidelines set forth below:

- Tuition reduction does not include performance fees, private lessons, master classes, or any expense outside of academy tuition. Tuition reduction applies to academy tuition only, awards are offered for the 2019-2020 academy session and not the summer programs.
- Tuition reduction is awarded on a year-to-year basis. In other words, even if you have received financial assistance in years past, you must be reconsidered annually.
- Tuition reduction awards with Colorado Ballet is made with no consideration of race, nation of origin, or gender.
- The yearly amount of tuition reduction is based on artistic merit and financial need.
- Artistic merit is at the sole discretion of the Academy Director, Academy Principal and Instructors.
- Colorado Ballet Academy may reduce or withdraw awards at any point during the year for students missing classes or failing to meet expectations.
- Financial need is determined based on the supporting documents requested of you. Proof of income can come in the form of your 2018 tax return (preferred) or a W-2. The Committee may request additional information from you to determine your need.
- All decisions are final.
- Tuition reduction applicants agree to abide by all of the policies set forth in the 2019-2020 school registration packet.
- No exceptions will be made to any of the policies stated above.
